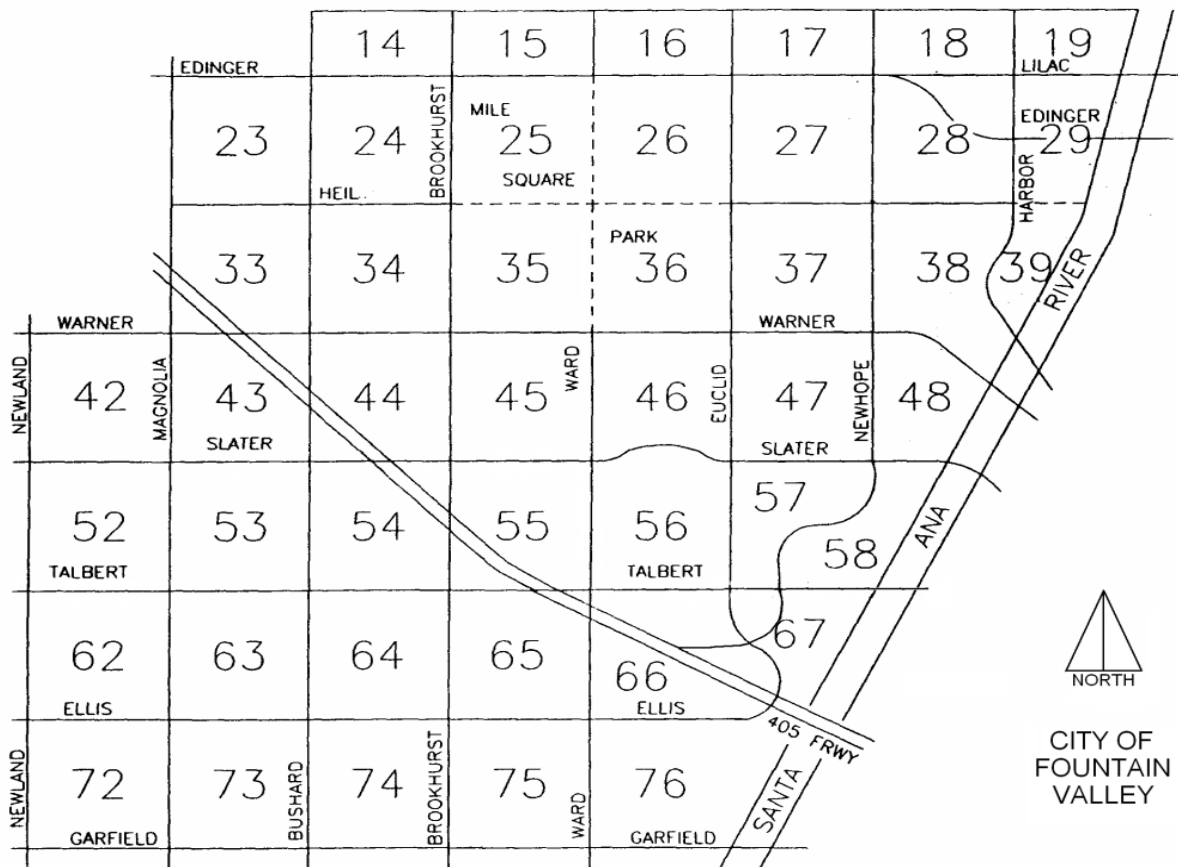

COYOTE AWARENESS



There are many steps that can be taken to protect you and your property from animals like coyotes and other wildlife.

Some of these include:

- Fence off animal enclosures (fully enclosed if possible).
- Keep cats and small dogs indoors or in the close presence of an adult.
- Feed pets indoors.
- Store trash in covered heavy-duty containers.
- Keep yards free from potential shelter such as thick brush and weeds.
- Enclose the bottoms of porches and decks.
- Eliminate potential food and water sources, such as fallen fruit and standing water.
